Membership Policy

Terms and Conditions

1.Membership Payment

- 1.1 Annual Payment: The membership fee of £10 is payable in full at the time of registration.
- 1.2 Renewal: Membership is valid for one year from the date of registration. Members will need to renew their membership annually to continue receiving benefits.
- 1.3 Membership fee is only available for upfront payment annually.

2. Referral Bonus

- 5.2 Termination by Us: We may terminate the membership immediately if there is any breach of terms, including non-payment or fraudulent activity. In such cases, no refund will be provided, and any outstanding payments will be pursued.
- 5.3 Early Termination: If a member wishes to cancel their membership early, they must provide written notice. The membership fee will be non-refundable.
